

**TRIPLE O'S – ON-THE-GO & MORE CONTEST**  
**("Contest")**

**RULES AND REGULATIONS**

CONTEST BROUGHT TO YOU BY WHITE SPOT LIMITED ("TRIPLE O'S"). NO PURCHASE NECESSARY. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO PARTICIPATE IN THE CONTEST YOU MUST READ AND AGREE TO THESE RULES AND REGULATIONS. PARTICIPATION IN THE CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE RULES AND REGULATIONS (AS THE SAME MAY BE AMENDED BY WHITE SPOT LIMITED FROM TIME TO TIME IN ITS SOLE DISCRETION). **(1) CONTEST PERIOD:**

The Contest will begin at 12:01 AM (Vancouver time) on September 10th, 2018 and end at 11:59 PM (Vancouver time) on September 28<sup>th</sup>, 2018 (the "Contest Period").

**(2) ELIGIBILITY:**

In order to be eligible to win a prize, an entrant must be a resident of British Columbia and must not be (and no member of his/her immediately family shall be) an employee of White Spot Limited or any affiliate of the foregoing. For the purposes of these Rules and Regulations, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether by blood, marriage or adoption and whether or not they reside in the same household.

White Spot Limited shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to White Spot Limited for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. White Spot Limited reserves the right to disqualify any entry or entrant in its sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

### **(3) HOW TO ENTER:**

No Purchase Necessary. To enter the Contest, please follow these steps:

- Complete entry form including name, age, address, phone number, email address, city, province, postal code, phone number, skill testing question & submit in entry box.
- Complete and submit the online form on the Triple O's dedicated contest web page.

There is a limit of one entry per person, per day.

### **(4) PRIZE DETAILS:**

There is one grand prize consisting of: On-The-Go Truck catering for the winner and 50 friends (a total of 51 people and up to \$1200 value) and 5 (five) secondary prizes consisting of \$100 Triple O's gift cards.

Location of On-The Go-Truck catering event is restricted to the Metro Vancouver area only and is based on the Triple O's truck availability (some blackout dates apply including no booking in July or August). Must be redeemed by December 31, 2019. If the randomly drawn winner resides outside of Metro Vancouver, the prize "On-The-Go Truck catering for the winner and 50 friends" will be provided alternatively in the form of 12 (twelve) \$100 Triple O's gift cards representing the value of the truck event.

Gift cards can be used at participating Triple O's locations (excluding but not limited to: Rogers Arena, PNE/Playland, Pacific Coliseum, BC Ferries, and Langley Events Centre and select universities/colleges).

Gift cards can be used on single or multiple visits with any unused balance on the gift cards to be used upon subsequent visits within an unlimited time frame.

Odds of being selected as the winner depend on the number of entries received.

### **(5) WINNER SELECTION:**

The grand prize and secondary prize winners will be selected randomly by a White Spot Limited representative at 10am on Monday, October 15<sup>th</sup>, 2018, and will be contacted by 5pm Wednesday, October 17<sup>th</sup>, 2018 by phone or email.

The selected entrants (or the parent or legal guardian of the selected entrants, where the selected entrant is under the age of majority) must also agree to sign and return White Spot Limited Standard Declaration and Release Form.

If any selected entrant does not meet all the Contest conditions or does not reply within seven (7) days of the initial documented contact attempt by White Spot Limited, that entrant will be disqualified and White Spot Limited shall be entitled to select a new entrant from amongst the remaining eligible entries.

Once a potential winner for a prize is determined, the winning entrant will be directed as to how to claim their prize, which will be delivered within a reasonable time.

#### **(6) GENERAL RULES:**
